## CHARACTERS

(1 M, 1 F, 1 flexible)

**MAGICIAN:** Craigslist magician known as “The Great Marvin” who lives in his parents’ basement; wears a magician’s costume with “The Great Marvin” written on it; wears a magician’s hat and carries a magic wand; flexible.  
Note: If female, change name to “The Great Marvenne.”

**CLAIRE:** Allen’s wife; hired a magician off of Craigslist for her son’s birthday party; female.

**ALLEN:** Claire’s husband; wanted to hire a clown for his son’s birthday party; male.

## A DISAPPEARING

(AT RISE: A suburban home where a children's birthday party is underway. There is a table with birthday presents and a birthday cake on it. Excited Children can be heard in the next room. Frantic, Allen enters.)

ALLEN: *(To offstage.)* Here. In here.

CLAIRE: *(From offstage, frantic.)* What was that?

ALLEN: *(Urgent.)* Come in here.

*(Claire and Magician enter.)*

CLAIRE: *(To Magician.)* What just happened out there?!

ALLEN: *(To Magician.)* What was that?

MAGICIAN: *(Still in shock.)* I don't know!

ALLEN: Did I see what I *think* I just saw?

MAGICIAN: I-I-I can't explain that.

CLAIRE: Did you actually —?

ALLEN: *(To Magician.)* How did you *do* that?

MAGICIAN: *(Stumped.)* I don't know.

ALLEN: *(Trying to wrap his head around it.)* How in the world did that actually happen?

CLAIRE: Shhh! Keep your voice down. The kids will hear you!

ALLEN: The kids will hear me? Are you serious? After what they all just *saw*?

CLAIRE: They don't understand what they saw. They probably think it's a game.

ALLEN: A game?

CLAIRE: Yes! Tommy is *hiding*. They're all running around looking for him.

ALLEN: *(To Magician, pointedly.)* But they're not gonna find him, are they?

MAGICIAN: I don't think so. No.

CLAIRE: Where is he?

MAGICIAN: Well...full disclosure...I'm not sure.

CLAIRE: What?!

ALLEN: *(To Magician.)* How do you not know?!

MAGICIAN: I-I'm just as surprised as you are.

ALLEN: I don't think that's possible.

MAGICIAN: I don't know *exactly* how it happened. I mean, I know *what* happened...kind of. But I'm just not clear on how I...actually did it.

CLAIRE: How do you not know that? You're a magician!

ALLEN: And what about that puddle of green ooze on the floor where he was standing? What is that?

MAGICIAN: I'm guessing that's ectoplasm.

ALLEN: Ectoplasm?

CLAIRE: *(To Magician.)* What is ectoplasm?

MAGICIAN: It's an ethereal substance produced by the transference of energy during the dematerialization process.

ALLEN: Ethereal substance?

CLAIRE: *(To Magician.)* Is that going to come out of the carpet?

MAGICIAN: Think of ectoplasm as...it's kind of like...a piece of the kid's soul.

CLAIRE: What?

MAGICIAN: *(Hedging.)* Well...

CLAIRE: *(Hysterical.)* Oh, my gosh! His *soul*? Oh, my gosh!

MAGICIAN: Maybe more like...spiritual afterbirth.

CLAIRE: And you have no idea where he is?

MAGICIAN: Not exactly. No.

ALLEN: But you can bring him back from wherever it is you sent him, right?

MAGICIAN: Theoretically, yes.

CLAIRE: Theoretically?!

MAGICIAN: I mean, I should be able to get him back...I think. I'm just not sure I know how I...how to *do* that.

ALLEN: So, you have no idea how you disappeared him and no idea how to get him back?
